## **Old Business**

**Item 5.a 2015 Operating & Capital Budgets** As with all Alberta municipalities, the impacts of recent world events have the potential for significant negative financial consequences for all of us. As such, the budgets presented reflect Council's desire to minimise spending while at the same time, recognising that investments in capital infrastructure and municipal reserves will help to ensure long-term viability for our community.

The 2015 Operating Budget as presented identifies a 3.25% municipal taxation increase with the following significant highlights:

### **INCREASES**

- Regional Sewer Line expenses (new) = \$294,000.00 Additional
- Partial repayment of 2014 Garbage & Recycling cart costs = \$18,000.00 into Reserves.
- Budgetary Contribution of \$92,600.00 into new Capital Projects.

### **REDUCTIONS**

- Regional Water Line Expenses (existing) = \$91,000.00 Reduction
- Councillor Expenses (existing) = \$14,300.00 Reduction
- 20 Street Loan Payments Now Completed = \$66,000.00 Reduction

It is important to note that although the budget identifies a 3.25% municipal taxation increase, provincial School requisitions have not yet been set. As such, the School portion of municipal taxes in Bowden is not yet finalised. And, given that the areas east of Highway II are subject to provincial annexation conditions, taxation rates for those areas are directly tied to Red Deer County taxation rates. Once all information is finalised, Budget amendments will be brought forward for Council deliberation as may be necessary. At that time, the 2015 Bowden Tax Rate Bylaw will also be brought forward for Council deliberation.
