Old Business

Item 5.a Director of Emergency Management Appointment The term for Mayor Robb Stuart, the Town of Bowden's current Director of Emergency Management, expires on June 30, 2012. As such, Council re-appointed him for an additional 6 month term.

New Business

Item 6.a Bowden Daze Street Dance request The attached documentation from Andre and Cathy Aucoin (Pizza 20/20) indicates that they would like to sponsor a teen street dance on the Saturday night of Bowden Daze from 8:00 p.m. till 11:00 p.m. Council members expressed that this was a wonderful idea and that this will give our town's youth a great opportunity for a fun evening.

Motion 6.a Moved by Councillor Steve Blamire that Council approves the request from Andre and Cathy Aucion to sponsor a teen dance in conjunction with Bowden Daze on Saturday July 28, 2012.

Item 6.b Recycling Centre Discussions At the June 14, 2012 Public Open House, the question of the future of the Town of Bowden's Recycling Centre was posed to the residents in attendance. Council has been wrestling with the long-term options for this facility for some time. Costs to run this facility are now almost tripled from when it began and its usage by non-residents has vastly increased. To try to reduce the unsightly impacts of abuse and garbage being dropped there, staffing costs are also now significantly increased. It is also a harsh reality that there are situations where, when the marketability of recycled items is soft, that some products are diverted into the regular waste stream. As such, Council members have made the very difficult decision to close this facility effective immediately. Once it is fully shut down, all residential recycling fees will be removed from municipal utility bills and the weekly garbage limits will be increased from a 3-bag maximum to a 5-bag maximum to compensate for the removal of the Town's recycling facility.

Motion 6.b.i Moved by Councillor Steve Blamire that Council directs Administration to proceed immediately with the closure of the Town of Bowden Recycling Facility located at 2102 . 20 Avenue in Bowden.

Motion 6.b.ii Moved by Councillor Sandy Gamble that upon closure of the Town of Bowden Recycling Facility, the weekly garbage limits will be increased from a 3-bag maximum to a 5-bag maximum to compensate for the removal of the Town's recycling facility and further, that upon closure all residential recycling fees will be removed from municipal utility bills.

Item 6.c Bylaw No. 10-2012 (Cemetery Bylaw) The existing Cemetery Bylaw, created in 2000 was in need of updating so volunteers from the Bowden Cemetery Association came together over several months to revise this document. Mayor Robb Stuart commended all of these volunteers who tirelessly worked to get the new Cemetery Bylaw in place. Their efforts resulted in a great document that will serve the municipality well for years to come. The following revisions were agreed to by Council members prior to giving First Reading to the Bylaw:

Section 3.6.b existing . The elected Executive of the Association shall be the first level of consultation regarding special requests +
revised . The elected Executive of the Association shall be consulted regarding special requests +

Section 3.6.c existing . The elected Executive of the Association shall be the first level of consultation regarding permission for access +
revised . The elected Executive of the Association shall be consulted regarding permission for access +

Motion 6.c.i Moved by Councillor Sheila Church that Council gives First Reading to Bylaw 10-2012 (Cemetery Bylaw).

Item 6.d Bowden PAC donation request The attached letter from Shari Robertson (Bowden PAC chair) outlines that they are planning a BBQ and %opportunity fair+on September 13, 2012. They request that Council consider a donation towards this event.

Motion 6.d Moved by Councillor Steve Blamire that Council directs Administration to mail out a \$200.00 donation to the Bowden PAC to be used towards holding a BBQ and %opportunity fair+on September 13, 2012. **MOTION CARRIED**

Item 6.f Newsletter Advertisements The business card advertisement section of the Town of Bowden newsletter has proven to be quite popular with local business owners. Current policy is that only in-town licensed business owners are able to take advantage of this service. A number of phone calls have come in from out of town businesses that are not necessarily licensed in Bowden that also wish to take advantage of this advertising opportunity. Council members expressed that there should be a three-tiered payment option whereby in-town businesses pay \$10.00 per month, Red Deer County businesses pay \$15.00 per month and other businesses pay \$20.00 per month. This would help ensure that non-local advertising is not being subsidised by tax dollars.

Motion 6.f Moved by Councillor Steve Blamire that Council approves Administration's request to open up the business card advertisement section of the Town of Bowden newsletter to other businesses at the following rates: whereby in-town businesses pay \$10.00 per month, Red Deer County businesses pay \$15.00 per month and other businesses pay \$20.00 per month (all rates are plus G.S.T.). **MOTION CARRIED**

Item 6.g Golf Course Request The attached letter from the Bowden Golf Course Senior Fun Day Committee requests that Council consider a donation towards the Bowden Hiway Senior Open Golf Day being held on July 17, 2012.

Motion 6.g Moved by Councillor Sheila Church that Council directs Administration to mail out a \$100.00 donation to the Bowden Gold Course along with a selection of promotional Town of Bowden merchandise to be used towards the Bowden Hiway Senior Open Golf Day being held on July 17, 2012. **MOTION CARRIED**
